The Terry Town Council met in regular session at Terry Town Hall at 6:00 p.m. with Mayor Rolane Christofferson presiding. Council members present were Cindy Bond, Brad Eaton, Caryn Rein, and Peter Leyva. Also present were Clerk Lynn Schilling, Public Works Director James Schilling, Deputy Clerk Holly Eaton, Ryan Rittal (Stahly Engineering), Michael O'Neill, Tim Therrien (Prairie County Sheriff's Department), and Fire Chief Brad Davis.

Mayor Rolane Christofferson called the meeting to order at 6:03 p.m. and led the Pledge of Allegiance.

Public Comment- None.

Minutes from the November 10th, 2016 meeting were approved. (Rein/Eaton)

Claims approved per Claims Committee with the exception of the Prairie County claim for the Public Safety Interlocal. (Rein/Eaton)

Cash/Bank Reconciliation approved. (Bond/Rein)

After review of the Stockman Bank Investment Fund account \$655,834.25 will be the amount in the Stockman Bank Investment Fund for the month of December.

(Eaton/Bond) Interest is deposited in the amount the end of each month.

Balance as of 10/31/16--\$652,402.83 Interest paid 11/30/16--\$186.51 Balance as of 11/30/16--\$655,834.25

Credits-\$57,352.03 Debits-\$53,920.61.

Unfinished Business

Ryan Rittal (Stahly Engineering) stated that he did not have any new information to present to the Town Council. He discussed the proposed timeline in including Phase 1, the replacement and re-routing of the sewer main, in the project. Mayor Rolane Christofferson stated that there was a long list of items requested by the USDA as part of their application process for the Wastewater Loan and Grant program. Ryan Rittal suggested a conference call with himself and Beth Epley (EPEDC) to discuss funding options.

Fire Chief Brad Davis provided the Town Council with a written report of the previous month's activity by the fire department. He discussed the structure fire that occurred and the department's response. He stated that personnel did well. Their response time was seven (7) minutes. They performed well in considering the three (3) priorities- life safety, incident stabilization, and property conservation— everyone was kept safe and they were

able to save many of the family's belongings. He has touched base with Prairie County Sherriff Duncan Hedges regarding collaboration in securing the scene to eliminate additional distractions to the responders and concerns of bystander safety. The surplus fire trucks did not sell. They are following up with some other options in disposing of the trucks. Fire Chief Brad Davis also noted that the fire engine was in the light parade, he was able to discuss briefly with the County Commissioners the well house that is jointly owned, and there are several education opportunities in the area including a Fire Investigation course that he attended. Town Council passed a motion approving the purchase of \$5,197 of equipment to outfit the new fire engine, \$3,739.95 in risk assessment tools and equipment for the fire department as well as proceeding with the replacement of the SCBA bottles over the next several years. (Leyva/Rein)

Tim Therrien (Prairie County Sheriff's Department) was present to report on public safety. He further discussed scene safety. No significant incidents other than the fire have occurred recently. Their department is now working to encourage and educate on cold weather safety.

In regards to Town/Fire Hall, Clerk Lynn Schilling and PWD James Schilling reported that the fire extinguishers in Town Hall and the Town Shop have been inspected this month.

Public Works Report:

- PWD James Schilling reported that the Peterbilt garbage truck has a recall and will need to be taken to Billings. All other equipment is functioning well.
- Mayor Rolane Christofferson shared with the Town Council reported concerns in regards to the intersection at Prairie and Custer. After discussion, Town Council requested PWD James Schilling to place yield signs at the intersection.

Clerk Lynn Schilling reported that there were four (4) rural garbage contracts that had not yet been returned and service has been discontinued.

There were no submitted building permits.

All other correspondence was reviewed.

New Business

Clerk Lynn Schilling reported delinquent sewer accounts for December: fourteen (14) friendly letters, zero (0) letter #2's and zero (0) letter #3's were sent.

Public Comment: None.

There being no further business, the meeting adjourned at 6:59 pm. (Eaton/Rein)
